- I, EDDIE KARST, of the City of Saskatoon, in the Province of Saskatchewan,
  Retired Peace Officer, MAKE OATH AND SAY AS FOLLOWS THAT:
- I have personal knowledge of the facts and matters herein deposed to except where stated to be upon information and belief and where so stated I do verily believe the same to be true.
- I was a member of the Saskatoon Police Service from 1954 to 1989,
   eventually retiring with the rank of Detective Sergeant. At the time of the death of
   Gail Miller I had the rank of Detective.
- 3. I was assigned to assist in the investigation of the death of Gail Miller. To this extent I interviewed and obtained statements from a number of people including David Milgaard. I testified at Mr. Milgaard's trial. I also testified before the Supreme Court of Canada in its review of the conviction of Mr. Milgaard. To the best of my knowledge and belief I was the only member of the Saskatoon Police Service who was summonsed to appear before the Supreme Court of Canada in this matter.
- I am 74 years of age. I am married and my wife and I have nine adult children. I am retired and living on my pension income which supports my wife and myself.

- I have been advised by the Saskatoon Police Service that I can expect to be called as a witness at the Commission of Inquiry into the wrongful conviction of David Milgaard.
- 6. I have contacted Mr. Aaron A. Fox, Q.C., Barrister and Solicitor of the firm of McDougall Gauley and have asked him to act as my counsel at the Inquiry. Mr. Fox advised me that he has been a member of the Bar in the Province of Saskatchewan since 1978. A copy of his Curriculum Vitae is attached hereto and marked as Exhibit "A" to this my Affidavit. He advised me that his present hourly rate is \$275.00 per hour.
- 7. Mr. Fox advised me that from time to time he would like to have junior counsel assist him at the Inquiry. He advises that there will likely be times when it will be more economical for junior counsel to attend at the Inquiry rather than Mr. Fox. He has indicated that has spoken with Mr. Christopher Boychuck of his firm who is prepared to assist in this matter. Mr. Boychuk's presently hourly rate is \$200.00 per hour.
- 8. Because the focus of the Inquiry will be a review of any and all aspects of the conduct of the investigation into the death of Gail Miller and the subsequent criminal proceedings resulting in the wrongful conviction of David Edgar Milgaard on the charge of the murder of Gail Miller I believe my role in the investigation of Gail Miller's death will be a significant aspect of the Inquiry.
- I have been advised by Mr. Fox that the Inquiry may be as long as three
  months. I do not know the extent or role of my participation at the Inquiry at this

time but I do know that I do not have the financial resources to retain the services of Mr. Fox at this Inquiry.

- 10. I have not asked for this Inquiry and it would be a significant financial burden on myself and my wife if I was not provided funding for legal counsel at the Inquiry. The alternative would be that I would be unrepresented by counsel at the Inquiry which would be equally unsatisfactory.
- 11. It is proposed that Mr. Fox will forward statements of account from time to time to the Inquiry for services rendered by him in representing me as counsel at the Inquiry which accounts will contain such particulars and will be subject to such review as the Commissioner may direct.
- 12. I make this Affidavit in support of my application that I be granted standing and funding at the Commission of Inquiry into the wrongful conviction of David Milgaard.
