On Sunday March 2/69, Dennis and Albert CADRAIN came to this station and discussed for a few minutes a matter with XXX. S/Sgt. ERADY and were in turn brought to the Det. office, to Supt. WCOD's office where I was in charge. These both boys, brothers, who live at 334 Ave. C. Sc. related a story to me in regards to the Gail MILLER murder and subsequently a statement was taken from both of these boys, the one of most importance from Albert CADRAIN by Det. KARSI and is self explanatory. This episode involving David Langenburg, Sask. and Nichol John female of Regina and Ron WILSON of Regina, who had apparently come here on the morning in question of the murder Jan. 31/69 and had later picked up Albert CADRAIN at his home at 334 Ave. C. Sol and later had proceeded that afternoon to Calgary, Edmonton, Calgary, Banff, Regina. According to Albert CADRAIN he was unaware of this murder until he returned home on Saturday March 1/69 and was told by his parents of this murder and he then with his brother discussed it and decided that one or all three of these persons may have been implicated. It was in my opinion at the time after having interviewe these boys for a considerable length of time probably one or two hours or more that there was something to this and it should be investigated. On Wed. March 5/69 Albert CADRAIN was again brought in by my request and another statement taken from him at which time he verified and stuck with his story and he was interviewed at that time by several members of this dept. and one Insp. RIDDELL of the RCMP and also S/Sgt.EDMUNDSCN, I might mention here that on Sunday March 2/69 after getting in touch with Supt. WOOD and Chief of Police James KETTLES that it was decided that Det. KARST would go to Winnipeg, Man. where it was learned through the assistance of Insp. RIDDELL that one David MILIGAARD who was here at that time was located in Winnipeg and Det. Karst was sent there and subsequently a statement was taken from MILIGAARD where of course he denied any knowledge of this murder. Also, it should be mentioned that on and around March 31 Insp. RIDDELL obtained a statement from Ron WILSON who was and is inthe Regina gaol and on March 11 another statement was obtained from Nichol John female who was in the city of Regina. Both these persons admitted having been in Stoon at the time but knew nothing of this particular murder. Cn Tuesday March 18/69, Det. KARST & myself took Albert CADRAIN to Regina and were in touch with the Regins City Police there and later we proceeded to the Regina gaol and interviewed Ron WILSON again, however, nothing further was learned from him and we also found his home and talked to Mrs. WILSON where there was some discrepancies found in the clothing that these boys both WILSON & MILIGAARD were wearing when they left Regina. Also female Nichol John was located in a hippie house in Regina and she was after considerable persuasion brought to the Regina gaol and interviewed by KARST and myself and was placed in a room with CADRAIN and allowed to discuss this matter and it was learned from her after this discussion that throught interrogation that she was of the opinion that CADRAIN was telling
